## *Rules For Usage of I.E.C. Facilities*

1. This agreement is subject to Resident Alim or Boards Approval.
2. All activities on I.E.C. premises must be in accordance with Islamic Principles.
3. It is the responsibility of the Host to inform their guests about the Islamic Principles strictly followed at the I.E.C. such as proper Islamic Dress Code (Hijab) and Mingling of Men and Women.
4. Date and time of program shall not conflict with that of I.E.C. Programs.
5. Identify a person who will be in charge of all the activities for the Program.
6. Member recommending the activity must be present at the Program.
7. No decorations or signs to be installed without prior written approval from I.E.C.
8. Only Halal products permitted at the facilities.
9. Kitchen area to be used by authorized I.E.C. personnel.
10. The Facility must be returned in the condition provided.
11. Deposit for the use of the Facility is \$200.00
12. Donation to offset usage expenses is as follows:  
Members - \$100.00    Non-Members - \$200.00
